Caregivers of older adults with Alzheimer's disease and other dementias supplied an estimated 18.1 billion hours in unpaid assistance, a contribution valued at approximately \$217.7 billion – and roughly 85 percent of that care was provided by family members. In 2015, the health care, long-term care and hospice costs for Americans with Alzheimer's disease and other dementias was estimated at \$236 billion.
